

**Community Education Council 28 Resolution  
Calling for Systemic Improvements in Co-Located  
District 75 Schools to Promote Equity, Safety, and Inclusion**

**APPROVED at the June 12, 2025 Calendar Meeting by a vote of the CEC D28 voting members present at the time of the vote (11 in favor / 0 opposed / 0 abstain / 1 absent)**

**WHEREAS**, District 75 (D75) schools serve students with the most significant disabilities across New York City, providing specialized instruction and support services critical to their educational and developmental growth; and

**WHEREAS**, many D75 programs are co-located within general education school buildings, sharing space, resources, and common areas;and

**WHEREAS**, the current model of co-location often results in inequitable access to facilities such as cafeterias, gymnasiums, libraries, playgrounds, and nurse's offices, as well as a lack of input in shared decision-making structures; and

**WHEREAS**, D75 students, staff, and families frequently report feelings of isolation, marginalization, and exclusion within co-located spaces due to inequitable treatment, poor communication between administrations, and insufficient cultural competence or disability awareness; and

**WHEREAS**, safe and supportive environments are essential for all students, particularly those with complex needs, and inadequate co-location practices may contribute to unsafe conditions, bullying, and denied opportunities for social-emotional and academic inclusion;and

**WHEREAS**, true equity requires not only physical access but also a culture of respect, collaboration, and mutual accountability between co-located schools;

**THEREFORE, BE IT RESOLVED** that the Community Education Council for District 28 (CEC28) calls upon the New York City Department of Education (NYCDOE) to:

1. Establish Mandatory Co-Location Agreements that are collaboratively developed with D75 administrators, parent leaders, and staff to ensure equitable access to shared facilities, schedules, and school-wide opportunities.

2. Create a Standardized Co-Location Framework that defines clear expectations and protocols for equitable treatment, regular joint planning, and conflict resolution between all co-located schools.
3. Appoint a Dedicated Co-Location Liaison in each borough to support relationship-building, monitor compliance, and serve as an ombudsperson for resolving co-location concerns between general education and D75 programs.
4. Provide Mandatory Inclusion and Disability Awareness Training for all school-based staff and administrators in co-located schools to build a culture of respect, understanding, and collaboration.
5. Ensure Parity in School Leadership Structures, including shared representation in School Leadership Teams (SLTs), Building Councils, and all safety and equity committees.
6. Audit and Remedy Facilities Disparities in co-located schools to guarantee that D75 students have equal access to clean, safe, and appropriate instructional and recreational spaces.
7. Elevate the Voices of D75 Families and Students in co-located settings by creating inclusive feedback mechanisms and requiring meaningful parent engagement across all school communities.

BE IT FURTHER RESOLVED that this resolution be shared with the Panel for Educational Policy (PEP), Community Education Councils (CECs), the NYCDOE Chancellor, and relevant elected officials to advocate for the systemic changes necessary to ensure that <sup>1</sup>Students in District 75 are treated with dignity, equity, and care, regardless of their school's co-located status.
